Preliminary considerations

- ◆ Discrepancies in details NOT necessarily invalidate the main issue.
 - time of crucifixion
 - murder weapon
- ★ Fact that all the accounts not read exactly the same, rather than prove them unreliable, show they were NOT written in collusion.

But, DO the witnesses contradict one another?

If two statements that seem contradictory can be explained by any rational hypothesis, the discrepancy has not been established. Seeming contradictions may appear because speakers and writers may omit details, which if known, would have explained the apparent discrepancy.

I - WHEN women came to the tomb

Mt 28:1 "as it began to dawn"

n 20: I "while it was still dark"

— vs —

Mk 16:2 "when the sun had risen."

ANS: left vs arrived - NO contradiction!

2 - WHO went to the tomb

- n = 20: = one woman
- Mt 28:1 = 2 women
- Mk | 6: | = 3 women
- Lk 24:10 = 3 women +

- NONE say ONLY one/s—If ALL, all true!
- Jn 20:2 "we"
- "I went to the rodeo" ONLY person?!
- Specifics do not exclude

3 - NUMBER OF ANGELS seen at tomb

- Mt (28:2,5) & Mk (16:5) mention one
- Lk (24:2) & Jn (20:12) mention two

- NONE say ONLY one/s—If TWO, all true!
- "I saw Mary at the mall today" ONLY person you saw?!

4 - CONDUCT of the women

- Mt 28:7; Mk 16:7 told to go to dis. & report
- Lk 24:9, 10 they did

— vs —

Mk 16:8 "said nothing to anyone"

- to anyone BUT the disciples Syn. of genus.
 Cmpr Mk 16:20; Jn 3:32. - Illus: Disneyland "What see?" "everything"
- WHO afraid of? ("for") ...NOT disciples

5 - FIRST APPEARANCE to MALE disciples

- Mt 28:10,16 mountain in Galilee
- Mk; Jn 20:19 in Jer. on Sun after resurr.
- Lk 24:34; ICo I5:5 to Peter

- NONE say "first" nor "only"!
- Illus: two people describe wreck...

6 - JERUSALEM or GALILEE?

• Mt 28:16; Jn 21:1 - meet in Galilee

___ vs ___

• Lk 24:33,36,49,52 - in Jer. & remain there

- Lk 24:36-49 v44f, later ... "Now..."
- Luke ≠ chronological
- Lk 24:50 ... Ac 1:3 "forty days"?!

7 - The "FORTY DAYS" of Ac 1:3 contradicts Lk. 24:36-53

- Ac 1:3f additional infor. & instruct.
- Luke AND Acts to Theophilus
- Illus: "discussed some things with corporate office"... Later, mention this interaction (emails, phone) took place over several weeks...contradiction?!
