

6 Pilate

- 1. Asks King of Jews 2nd time. Jesus says yes.
- 2. Pilate asks what is truth?
- 3. Offers to release someone drop charge.
- 4. Has Jesus scourged.
- 5. Riot forming.
- 6. Pilate becomes afraid when Jesus says He is Son of God.
- 7. Gives in to their demand when political pressure applied.

Do not know.

Q27.6 Who are these in 21:15?

Other disciples.

Q27.7 Who are the sheep?

His disciples (beyond His apostles).

Q27.8 What does this say about who and what the focus should be in the Apostles' work?

Jesus Disciples and being servants to them.

Q27.9 Why has this discussion with Peter and not the rest of the Apostles?

Peter was the leader of the Apostles and did have the problem of denying the Lord.

Q27.11 What was Peter asking the Lord about John?

When was John was going to die.

What is that to you? Follow Me.
